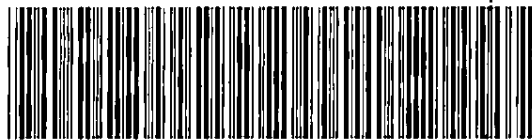

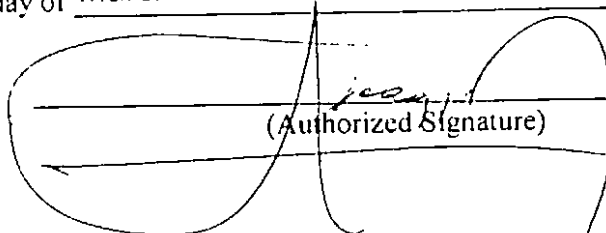

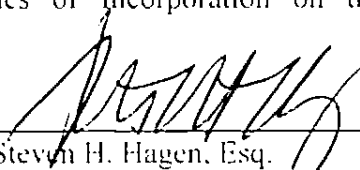
ARTICLE IX. BYLAWS
