# ARTICLES OF INCORPORATION

We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

#### **ARTICLE I**

THE NAME of the Corporation shall be:

#### **ARTICLE II**

THE CORPORATION may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

# **ARTICLE III**

THE MAXIMUM number of shares of stock which the Corporation shall have outstanding at any time, shall be **ONE HUNDRED** (100) shares of stock which shall be common stock of a par value of **FIVE DOLLAR** (\$ 5.00) per share. All or any part of the capital stock may be paid for either in lawful monles of the United States of America, or in services, at a true valuation thereof.

#### **ARTICLE IV**

THIS CORPORATION shall begin business with a minimum capital in the amount of FIVE HUNDRED DOLLARS ( \$500.00 ).

#### **ARTICLE V**

THIS CORPORATION shall have perpetual existence.
