**ARTICLES OF INCORPORATION
OF

**ARTICLE I
NAME**

The name of the corporation is **FCN BERTHA FONSECA MD, INC** (hereinafter referred to as the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE**

The Corporation is authorized to issue 1 share of common stock, par value \$0.01 per share.


**ARTICLE VIII
