**ARTICLES OF INCORPORATION
OF

**ARTICLE I
NAME**

The name of the corporation is **FCN JEFFREY STEINBERG MD, INC** (hereinafter referred to as the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE**
