#### ARTICLES OF INCORPORATION

#### DEVOTED HEALTH INSURANCE COMPANY

The undersigned incorporators, pursuant to Chapters 607 and 628, Florida Statutes, adopt these Articles of Incorporation of Devoted Health Insurance Company, a stock insurer.

## ARTICLE I ORGANIZATION

The Corporation is a company organized under Chapter 607, the Florida Business Corporation Act.

#### ARTICLE II NAME

The name of the Corporation shall be Devoted Health Insurance Company (the "Corporation").

#### ARTICLE III EFFECTIVE DATE

The effective date of these Articles of Incorporation shall be the date of filing

#### ARTICLE IV PRINCIPAL OFFICE

The address of the Principal Office and the mailing address of the Corporation is 3350 SW 148<sup>th</sup> Ave., Suite 110, Miramar, Broward County, FL 33027. The location of the Principal Office and the mailing address shall be subject to change as may be provided in the Bylaws.

#### ARTICLE V PURPOSE

The purpose of the Corporation is to engage in the business of life and health insurance and any other activity or business now or hereafter permitted under the laws of the United States and of the State of Florida. The Corporation shall exist perpetually.

#### ARTICLE VI STOCK

The total number of shares of capital stock which the Corporation shall have the authority to issue shall be 10,000,000.00 shares, all of which shares shall be denominated "Common Stock," having a par value of \$1.00 per share. Pursuant to Section 628.121, Florida Statutes, the

Corporation shall maintain capital and surplus in an amount sufficient to comply with Sections 624.407 and 624.408, Florida Statutes, and other applicable provisions of the Florida Insurance Code, as may be amended from time to time.

#### ARTICLE VII SHAREHOLDERS

A majority of the shares of Common Stock of the Corporation shall be owned at all times, either directly or indirectly through one or more intermediate holding companies, by Devoted Health, Inc. ("Devoted").

For the purposes of this Article, a "majority of the shares of Common Stock of the Corporation" shall be defined as no less than 51% of the shares of Common Stock of the Corporation.

## ARTICLE VIII INITIAL REGISTERED AGENT AND OFFICE

Pursuant to Section 624.422, Florida Statutes, as amended from time to time, the Corporation's registered agent shall be the Chief Financial Officer of the State of Florida, whose address at the time of adoption of these Articles is as follows:

#### ARTICLE IV DIRECTORS

The number of Directors of the Corporation shall be no fewer than five (5), a majority of whom must be citizens of the United States. The Directors of the Corporation shall be elected by the shareholders as provided in the Bylaws and shall hold their offices for such period as the Bylaws shall establish, or until their successors are duly elected and qualified; <u>provided</u>, <u>however</u>, that the term of office of the initial directors shall not be for more than one year after the date of incorporation.

## ARTICLE X INDEMNIFICATION

The Board of Directors is hereby specifically authorized to make provisions for indemnification of directors, officers, employees and agents to the full extent permitted by law.

### ARTICLE XI SHAREHOLDER ACTION WITHOUT A MEETING

Any action required or permitted by Florida law to be taken at an annual or special meeting of shareholders may be taken without a meeting, without prior notice, and without a vote if the action is taken by the holders of outstanding stock of each voting group entitled to vote thereon having not less than the minimum number of votes with respect to each voting group that would be necessary to authorize or take such action at a meeting at which all voting groups and shares entitled to vote thereon were present and voted.
