ARTICLE V - RESTRICTIONS ON THE TRANSFER OF STOCKS


Shares of capital stock of this corporation shall be issued initially to the following corporation/persons in the amount set opposite their names

ARTICLE IX - CUMULATIVE VOTING

At each election for directors each shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.
