Please be advised that this corporation was formed without my consent. The corporation is a fraudulent device which a third-party is attempting to use to steal my identify and/or commit a fraud upon me.

I received copies of an account in which the fraudster was attempting to create or has created an account with Bank of America. I would appreciate your providing me with any information you have related to the person or persons who formed the corporation identified above. The only information I have been able to determine thus far is the e-mail address used to form the corporation. However, it is a gmail address and typically will be untraceable.

I have contacted the police and sheriff's offices related to the incident and my case number is 18-0041. The primary investigating officer is Kimberly Thompson. She can



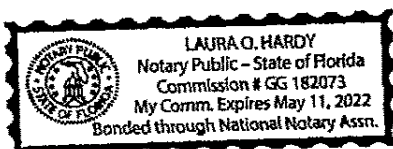
