# ARTICLES OF INCORPORATION OF BARTHVENTURE HOLDINGS, INC.

The undersigned, acting as incorporator of BARTHVENTURE HOLDINGS, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### **ARTICLE I. NAME**

The name of the corporation is BARTHVENTURE HOLDINGS, INC. (the "Corporation").
