**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of THE LIMITLESS - A COACHING GROUP, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is THE LIMITLESS - A COACHING GROUP, INC. (the "Corporation").


