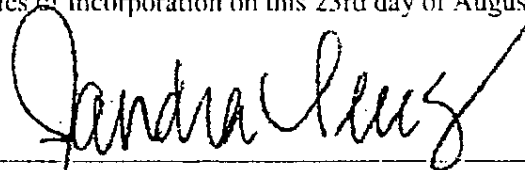
- FIRST: The date of filing of the Articles of Incorporation was March 20, 2018 and the Document Number is P18000026884.
