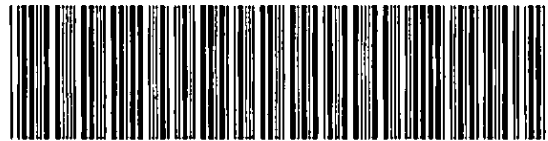

of



The corporation shall commence its existence upon the filing of these Articles of Incorporation.


