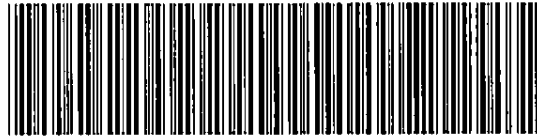

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is A PLUS CONTRACTING, INC., and the principal address and principal place of business is 12506 Elocin Dr., Thonotosassa, Florida 33592.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

## ARTICLE VI - AMENDMENTS




