

PROPERTY OR LABOR MAY ALSO BE PURCHASED WITH THE CORPORATE ATSU SUCH VALUATION AS MAY BE PIXED BY THE DIRECTORS.
- B. THE SAID STOCK SHALL BE ISSUED PURUANT TOA PLAN UNDER SECTION 1244 OF THE INTERNAL REVENUE SERVICE CODE.
