

The undersigned hereby makes, subscribes, acknowledges, and files with the Secretary of State of the state of Florida these articles of incorporation for the purpose of forming accordance with the laws of the state of Florida.

ARTICLE ONE NAME

The name of this Corporation shall be MOSS TRUCKING & FREIGHT, INC.

ARTICLE TWO DURATION; TERM OF EXISTENCE

This corporation shall begin existence on the date of filing of these articles with the Secretary of State of the state of Florida, and shall have perpetual existence thereafter.

ARTICLE THREE PURPOSE

The purpose or purposes for which the Corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE FOUR SHARES

This corporation is authorized to issue 10,000 shares of common voting stock. All or any part of the capital stock may be paid for in cash, in property, or in labor or services actually performed for the corporation. All stock shall be fully paid for when issued and shall be nonassessable.

Notice must be given by any Shareholder to the President or as Vice President of said Corporation not less than 24 hours prior to the time set for the holding of a Shareholders' meeting for the election of directors that said Shareholder intends to cumulate his vote at said election.

ARTICLE TEN SHAREHOLDER APPROVAL OF COMPENSATION OF DIRECTORS

The board of directors shall submit all proposals of directors' compensation to the shareholders of the corporation for approval, which approval shall require a vote of no less that 75% of those entitled to vote at a shareholders' meeting. No compensation shall be paid to the directors until it has been approved by the shareholders.

ARTICLE ELEVEN DIRECTORS

This corporation shall initially have one director. The number of directors may be increased or decreased from time to time in the manner set forth in the by-laws, provided that the corporation shall always have at least one director.
