**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
GLOBAL SHIPPING AGENCIES, INC.**

Pursuant to § 607.1006, Florida Statutes, the undersigned, being the President of GLOBAL SHIPPING AGENCIES, INC., a Florida corporation (the "Corporation"), does hereby certify the following:

1. The name of the corporation is GLOBAL SHIPPING AGENCIES, INC.
2. The Articles of Incorporation were filed on March 21, 2018 and assigned Document Number P18000029560.
3. The Stockholders and Directors of the Corporation resolved to amend the Articles of Incorporation of the Corporation at a Special Meeting of the Stockholders and Directors of said Corporation, held on the 2nd day of January, 2024, with a quorum being present, at which time the following amendment to the Articles of Incorporation was approved by the Stockholders and Directors of the Corporation, viz:

"RESOLVED that the Corporation, Directors and Shareholders approve, confirm and ratify that the Articles of Incorporation of the Corporation shall be amended to increase the authorized number of shares of common stock from One Hundred (100) shares to One Hundred Fifty (150) shares with no par value per share."
4. The Amendment does not provide for the exchange, reclassification or cancellation of issued shares.
5. The date of the adoption of the Amendment set forth herein was January 2, 2024.
6. This Amendment was approved by the Stockholders of the Corporation and the number of votes cast for the amendment by the Stockholders was sufficient for approval. There was only one (1) voting group entitled to vote on this Amendment.
