#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Helron Marine Services, Inc. The initial principal office street and mailing address of the Company is 4216 Point La Vista Road, Jacksonville, Florida 33207.
