
STATEMENT OF FACTS

On or about April 16, 2018, Mark J. Albrechta, Esq. filed Articles of Incorporation as Incorporator forming Southeastern Asset Recovery Group, Inc. ("Southeastern") with the Division of Corporations in the State of Florida. In the Articles of Incorporation Mr. Albrechta named me as President of Southeastern.

I was not and am not aware of Southeastern nor do I serve as its President. Numerous attempts have been made not only by me, but also by my attorney, to contact Mr. Albrechta via e-mail, facsimile, phone, and certified mail to have the filing corrected. To date, Mr. Albrechta has never responded substantively to our efforts to correct the filing nor has the filing in fact been corrected. Due to Mr. Albrechta's unresponsiveness, I understand the thirty-day correction period under Section 0124 of the Florida Business Corporation Act has lapsed. Consequently, I am submitting this Statement of Facts to the Division of Corporations in the State of Florida to correct the public record.

The filing of Articles of Incorporation for Southeastern naming me as President constitute a fraudulent filing. I am not the President of Southeastern, am not an officer of or other responsible person for Southeastern, never consented to any involvement with Southeastern, and I am not otherwise connected to Southeastern in any way.
