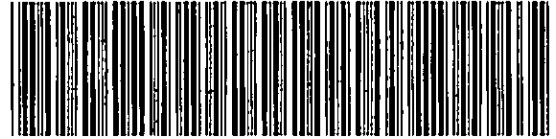

The undersigned, for the purpose of forming a for-profit corporation under the law of the State of Florida, do here by adapt the following Article of Incorporation.

Article I
Name
