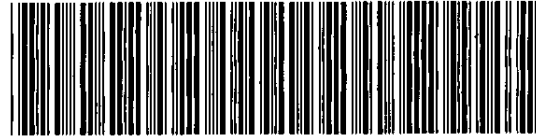

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
PURPLEFULL FOODS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation (defined below) hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Purplefull Foods, Inc. (the "Corporation"), with the following Florida corporation Document Number: P18000038078. The Corporation's EIN is: 82-5379079.
2. The text of the amendment to the Corporation's Articles of Incorporation is as follows:
 - a. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"The name of the corporation shall be CBYMF Group, Inc. (the "Corporation")."
 - b. Article II of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"The street and mailing address of the initial principal office of the Corporation is 1623 E. Concord St., Orlando, FL 32803."
 - c. Article V of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"The board of directors of the Corporation shall consist of one (1) director. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws but shall never be less than one (1). The name and address of the individual who will serve as director of the Corporation is:

Cathy Matthews, 1623 E. Concord St., Orlando, FL 32803."
 - d. Article VI of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"The street address of the registered office of the Corporation is: 1623 E. Concord St., Orlando, FL 32803. The name of the registered agent of the Corporation at that office is: Cathy Matthews."
 - e. Article IX of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"The effective date and time of these Articles of Incorporation shall be the date and time that these Articles of Incorporation are filed with the Florida Department of State, Division of Corporations."
