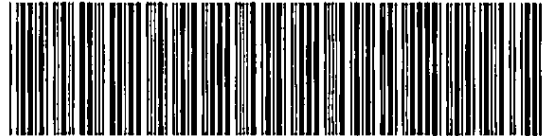




**ARTICLE X.**


