ARTICLE VI LIABILITY OF DIRECTORS

No amendment to or repeal of this Article VI shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to such amendment.

ARTICLE VII INDEMNIFICATION OF DIRECTORS

The Corporation shall indemnify, advance expenses, and hold harmless, to the fullest extent permissible by the laws of the State of Florida, any person made or threatened to be made a party to an action or proceeding. whether civil or criminal, by reason of the fact that he, his testator or intestate, then, is, or was a Director or Officer of the Corporation, or then serves or has served on behalf of the Corporation in such capacity at the request of the Corporation, against reasonable expenses, judgments, fines, and amounts actually and necessarily incurred in connection with the defense of such action or proceeding or in connection with an appeal therein. Such right of indemnification shall not be deemed an exclusive of any other rights to which such person may be entitled.
