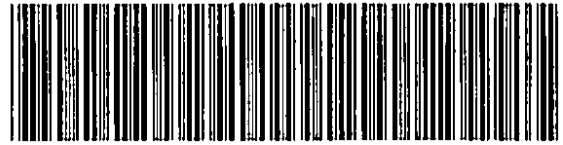

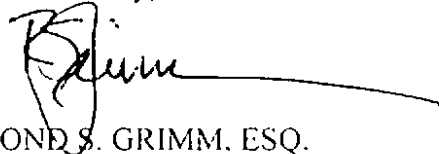

ARTICLES OF INCORPORATION
OF
MESQUITA ENTERPRISES, INC.

ARTICLE I

CORPORATE NAME

1.1 The name of this corporation is Mesquita Enterprises, Inc.

1.2 The street and mailing address of the initial corporate office of the corporation is 3920 Brown Ave., Sarasota, FL 34231.

ARTICLE II

CAPITALIZATION AND STOCK

2.1 The aggregate number of shares that the Corporation shall have authority to issue is one hundred (100) shares. All such shares shall be designated as common stock.

ARTICLE III.

PREEMPTIVE RIGHTS

3.1. Shareholders shall have preemptive rights to acquire the corporation's unissued shares.

6.1 The Board of Directors shall consist of two (2) directors. The names and addresses

2 6.2 In the event that the number of directors is increased according to the bylaws of the
3 corporation, all of the directors shall be elected at the annual meeting of the shareholders. There shall
4 be no staggering of terms of the directors.

5 6.3 Unless otherwise provided in these articles or the bylaws of the corporation, the Board
6 of Directors shall have no authority to amend any provision of the articles of incorporation without
7 the majority agreement of the shareholders.


8 6.4 Unless otherwise provided in these articles or the bylaws of the corporation, the Board
9 of Directors shall have no authority to amend or repeal the bylaws of the corporation without the
10 majority consent of each voting group entitled to vote on any proposed amendment.

12 **STATUTORY CORPORATE POWERS**

13 7.1 Pursuant to F.S. 607.0202(3), these articles of incorporation need not set forth any of
14 the statutory corporate powers enumerated in Ch. 607, Florida Statutes, the Florida Business
15 Corporation Act.

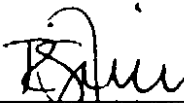
