ARTICLES OF INCORPORATION

OF

SARI L. TROTMAN, P.A.

The undersigned subscriber to these Articles of incorporation, is a natural person competent to contract, hereby associate themselves together to form a professional association under the Laws of the State of Florida providing for the formation of corporation for profit with the powers, rights, privileges, and immunities hereinafter mentioned, and they hereby make, subscribe, and acknowledge and file with the Secretary of State of the State of Florida this Certificate of Incorporation; and to that end they do, by this Certificate, set forth the following Articles of Incorporation.

ARTICLE I

The name of this Professional association shall be: **SARI L. TROTMAN, P.A.**

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on are directed to the profession as a nurse practitioner in the medical field and to do any and all things allowed and permitted to be done by professional association under the Statutes of the State of Florida, and to do any and all the things hereinafter mentioned, as fully and to the same extend as natural persons might or could do, it wit:

a. Engage in every phase and aspect of the general practice as a nurse practitioner; provided however, that the professional services involved in the business practice in the medical field shall be rendered only through those of its directors, officers, employees and agents who are duly licensed and authorized to practice in the State of Florida; and

b. Invest the funds of the business and to purchase, own, hold, rent, lease or otherwise acquire or dispose of real and personal property; provided, however, that such investments and property are necessary for or incidental to the practice of medicine by this business.

c. The professional association may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

d. To carry on any or more of the purposes and objects hereunder enumerated as principal, factor, agent, contractor, or otherwise, whether alone or through or in conjunction with any person, partnership, association or professional association.

e. To such extent as a professional association organized under the laws of the State of Florida may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other professional association, corporation, firms or

Individuals, all and everything necessary, suitable, convenience, or proper for, or in connection with, or incidental to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interest of this professional association or to enhance the value of its properties; and in general, to do any and all things and exercise any and all powers, rights and privileges which a professional association may now or hereafter be organized to do or to exercise under the laws of the State of Florida or under any act amendatory thereto, supplemental thereto, or substituted therefore.

The foregoing clauses shall be construed as and shall be powers as well as purposes, and the matters expressed in each clause shall, unless otherwise herein expressly provided, be in no wise limited to reference to or inference from the terms of any other clause but shall be regarded as independent powers and purposes; and the enumeration of specific powers and purposes meaning of general terms or the general powers of the Professional association, nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature. This professional association shall be authorized to exercise and enjoy all other powers, rights and privileges granted by the laws of the State of Florida to a professional association organized there under, and all the powers conferred by all acts heretofore or hereafter amendatory of supplement to that statute, and the enumeration of certain powers as herein specified is not intended as exclusive of or as a waiver of any of the powers, rights or privileges granted or conferred by the statute now or hereafter in force; provided, however, that nothing herein contained shall be deemed to authorize or permit this professional association to carry on any business, to exercise any powers, or to do act which a professional association formed under that statute may not at the time lawfully carry on or do.

ARTICLE III

The maximum number of shares of stock that this professional association is authorized to have outstanding at any time is One thousand (1000) shares of stock of \$1.00 par value each.

ARTICLE IV

The amount of capital with which this professional association will begin business shall be no less than \$1000.00, represented by One Thousand (1000) shares of stock of One Dollar (\$1.00) each.

ARTICLE V

The initial post-office address of the principal office of this professional association in the state of Florida shall be the County of Broward, at 10590 SW 42 Court, Davie, FL 33328. The Board of Directors, may from time to time, move the principal office to any other address in the State of Florida.

ARTICLE VI

This professional association is to exist perpetually.

ARTICLE VII

The Registered Agent for this professional association shall be: Sari L. Trotman and the Registered Address shall be: 10590 SW 42 Court, Davie, FL 33328

ARTICLE VIII

This professional association shall have no less than One (1) Director initially. The number of Directors may be increased or diminished; from time to time By Laws adopted by the Stockholders but shall never be less than One (1).

Both Stockholders and Directors shall have the powers to hold their meetings and to have one or more offices within or without the State of Florida, and to keep the books of this professional association at such offices as the Stockholders and Directors shall determine, subject to the provisions of the Florida Statutes.

ARTICLE XIII

All rights conferred to stockholders herein are granted subject to the right the professional association reserves to amend, alter, change or repeal any provisions contained in this Certificate of incorporation, in the manner explained in Article XIV of this Certificate.

ARTICLE XIV

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed to them by the Stockholders and approved at a Stockholders Meeting by a majority of the stock entitled to vote, thereon, unless all of the Directors and all of the Stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

Article XV

The effective date of this professional association shall be on May 15, 2018.
