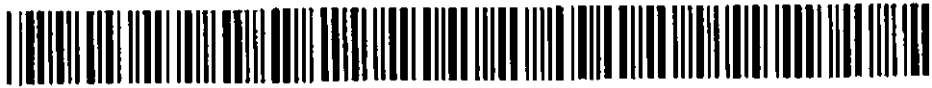

**ARTICLES OF INCORPORATION
OF
RESORTS LAND COMPANY, INC.**

THE UNDERSIGNED, acting as sole incorporator of Resorts Land Company, Inc. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation, pursuant to Section 607.0201 of the FBCA:

ARTICLE 1

Name

The name of the Corporation is: Resorts Land Company, Inc.

ARTICLE 2

Principal Office and Mailing Address

The address of the principal office of the Corporation is 3810-4 Williamsburg Park Boulevard, Jacksonville, FL 32257 and its mailing address is P.O. Box 57905, Jacksonville, FL 32241-7905. The location of the principal office and the mailing address shall be subject to change as may be provided in the Bylaws.

ARTICLE 3

Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000 shares of voting common stock having a par value of \$0.01 per share.

ARTICLE 4

Directors

This corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one. The name and address of the members of the first board of directors of the corporation are:
