**ARTICLES OF INCORPORATION  
OF  
*AF Facility Maintenance, Inc.***

The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of this corporation shall be **AF Facility Maintenance, Inc.**

**ARTICLE II  
EFFECTIVE DATE OF INCORPORATION AND TERM OF EXISTENCE**

The effective date of this incorporation shall be **May 15, 2018**. This Corporation shall have perpetual existence unless sooner dissolved according to law, and its existence shall commence on **May 15, 2018** as reflected in the Certificate of Incorporation issued by the Secretary of State of Florida.

**ARTICLE III  
NATURE OF BUSINESS**

The general purposes for which this Corporation is organized are the following:

- A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of this Corporation or necessary or desirable in order to accomplish them.

**ARTICLE IV  
INITIAL CAPITAL**

The amount of capital with which this Corporation shall begin business shall be determined in the sole discretion of the Incorporator and/or the Board of Directors.

The aggregate number of shares which this Corporation is authorized to issue is Five Hundred (500) shares of common stock. Such shares shall be of a single class and shall have a ONE DOLLAR (\$1.00) value per share.

**ARTICLE VI**  
**SPECIAL PROVISION - Indemnification**

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

**ARTICLE VII**  
**PRINCIPAL ADDRESS OF BUSINESS**

The principal address of business for this Corporation shall be 431 SE 2<sup>nd</sup> Ave., Pompano Beach, FL 33060 or at such other address as may be determined and fixed by the Board of Directors from time to time.

**ARTICLE VIII**  
**INDEBTEDNESS**

The outstanding indebtedness of this Corporation shall be unlimited.

**ARTICLE IX**  
**OFFICERS and DIRECTORS**

The number of director of this Corporation shall be not less than one (1) nor more than five (5) as may be provided for in the By-Laws of this Corporation. The By-Laws may provide for an increased or decreased number of directors, or change thereof. The names and post office addresses

**AMENDMENT**


