

The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be AF Facility Maintenance, Inc.

ARTICLE II EFFECTIVE DATE OF INCORPORATION AND TERM OF EXISTENCE

The effective date of this incorporation shall be May 15, 2018. This Corporation shall have perpetual existence unless sooner dissolved according to law, and its existence shall commence on May 15, 2018 as reflected in the Certificate of Incorporation issued by the Secretary of State of Florida.

The general purposes for which this Corporation is organized are the following:
