## Articles of Incorporation of 90 Miles Media, Inc.

*The undersigned incorporator files these articles on behalf of the shareholders of the Corporation all in accordance with Chapter 607 of the Florida Statutes*

### ARTICLE I NAME

The name of the Corporation shall be 90 Miles Media, Inc.

### ARTICLE II PRINCIPAL OFFICE MAILING ADDRESS

In addition, the Corporation shall pay for or reimburse any expenses incurred by such persons who are parties to such proceedings, in advance of the final disposition of such proceedings, to the full extent permitted by the Florida Business Corporation Act.
