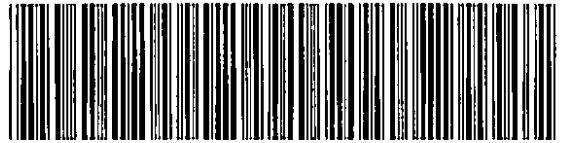

OF

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **Botanica Fine Gardening Inc**


ARTICLE EIGHT

ARTICLE TEN


The powers of the incorporators cease upon filing the Articles of Incorporation.
