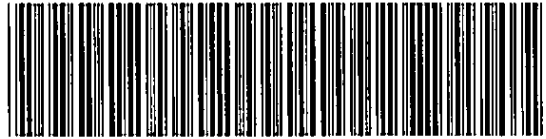

ARTICLES OF INCORPORATION

OF

A PROFESSIONAL CORPORATION

The undersigned, whom is duly licensed to engage in the practice of Real Estate Agent, within the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - CORPORATE NAME

This corporation shall exist perpetually unless dissolved according to Florida Law.
