
#### ARTICLE V - AUTHORIZED SHARES

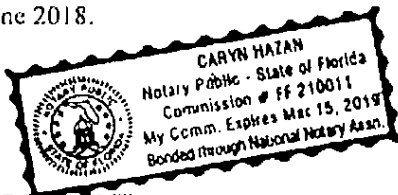




