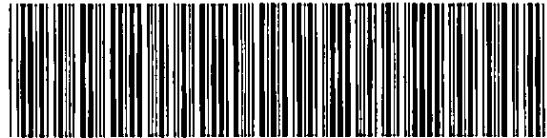

#### **ARTICLE X**



**ARTICLE XI**




