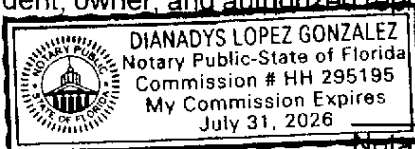
5. The Company's information has since been updated on sunbiz.org.
