### ARTICLES OF INCORPORATION OF BEHR CITRUS MANAGEMENT, INC.

### ARTICLE I

The name of this corporation is BEHR CITRUS MANAGEMENT, INC.

### ARTICLE II DURATION

This corporation shall exist perpetually, commencing as of the date of execution of these Articles of Incorporation.

### ARTICLE III INITIAL PRINCIPAL OFFICE
