# Attachment to Certificate of Incorporation of Viewz Marketing, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 130,000,000 of which 100,000,000 shares of par value \$0.001 per share shall be designated as Common Stock and 30,000,000 shares of par value \$0.001 shall be designated as Preferred Stock.
