# ARTICLES OF INCORPORATION FOR FLORIDA BENEFIT CORPORATION

## ARTICLE I. NAME

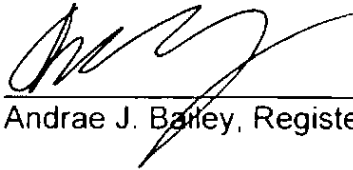

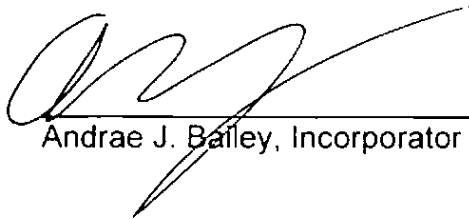
