**ARTICLES OF INCORPORATION**  
**OF**  
**SAFE STEP HOLDINGS, INC.**

**ARTICLE I**

The name of the corporation is Safe Step Holdings, Inc. (hereinafter called the "Corporation").

**ARTICLE II**

The address of the principal office and mailing address of the Corporation is 6028 Main Street, New Port Richey, FL 34653.

**ARTICLE III**

The purpose for which the Corporation is organized to transact any lawful business.

**ARTICLE IV**

The Corporation shall have the authority to issue (i) one thousand (1,000) shares of voting common stock having no par value and (ii) ninety-nine thousand (99,000) shares of non-voting common stock having no par value. Each issued and outstanding share of voting common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

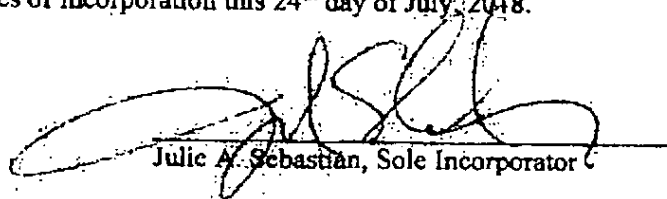
**ARTICLE V**
