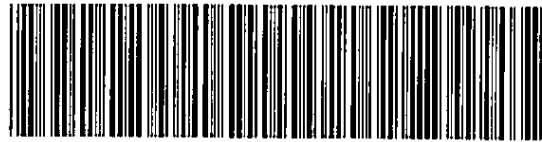



- To keep all accounting records for year 2018 at the same way as shown during the conversion process to Corporation. However any balance belongs to priors years will must pass through retained earning.


