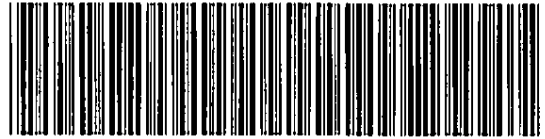

**ARTICLES OF INCORPORATION
OF
ROOFTOP LEADERSHIP, INC.**

Pursuant to the provisions of the Florida Business Corporation Act, Section 607 of the Florida Statutes, the undersigned incorporator files these Florida Articles of Incorporation in conjunction with domesticating this corporation in the State of Florida pursuant to Florida Statute §607.1801.

**ARTICLE I.
NAME OF CORPORATION**

The name of the corporation is **ROOFTOP LEADERSHIP, INC.**

**ARTICLE II.
PRINCIPAL OFFICE; MAILING ADDRESS**

The principal office of the corporation is located at 10127 Albyar Avenue, Riverview, FL 33578. The mailing address of the corporation is the same.

**ARTICLE III.
PURPOSE**

The purpose for which the corporation is to conduct any and all lawful business.

**ARTICLE IV.
AUTHORIZED SHARES OF STOCK**

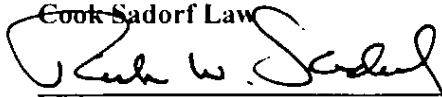
