**ARTICLES OF DISSOLUTION  
OF

Pursuant to the provisions of Sections 607.1401 and 607.1402 of the Florida General Corporation Act, ELITE MEDICAL BILLING AND CONSULTING, INC., a Florida corporation (the "Corporation") adopts the following articles of dissolution for the purpose of dissolving the corporation.
