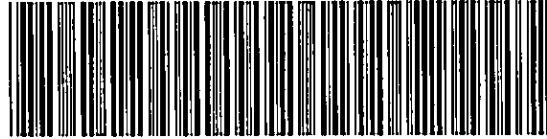

Pursuant to the provisions of Chapter 607 of the Florida Statutes, the undersigned corporation ("Corporation") adopts the following as its Articles of Incorporation:

ARTICLE 1. NAME

The name of the Corporation is Standard Leasing, Inc.

ARTICLE 2. PRINCIPAL OFFICE

The street address of the principal place of business of the Corporation and the mailing address of the Corporation is 742 Charlestown Circle, North Palm Beach, Florida 33410.
