

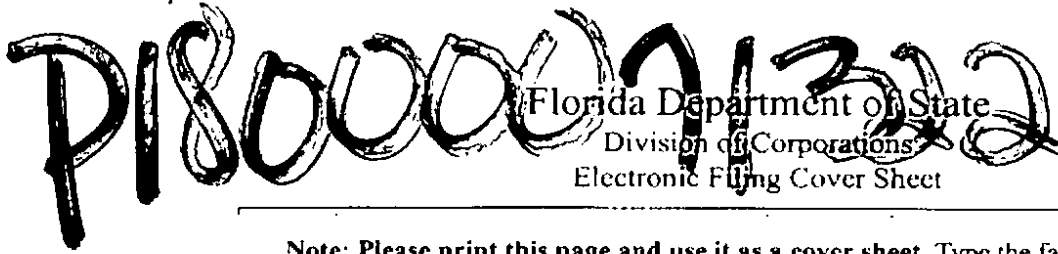

USM DEVELOPER GROUP, CORP.


SECOND: The date of the above amendment's adoption shall be November 27, 2018.
