ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF
DMIL 360 INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "FBCA"), DMIL 360 INC., a Florida corporation (the "Company"), hereby amends its Articles of Incorporation (the "Articles"), as follows:

1. Article VIII is hereby stricken in its entirety and replaced with the following:

Article VIII - Board of Directors

The Company shall have a Board of Directors (the "Board") consisting of between one and seven directors. The exact number shall be established from time to time by the resolution of the Board and may be either increased or diminished from time to time as provided in the bylaws.

3. This Amendment to the Articles was duly adopted in accordance with the provisions of the FBCA and were approved by the sole shareholder of the Company on September 27, 2018.

4. All other provisions of the Articles shall remain in full force and effect.
