ARTICLES OF INCORPORATION
OF
RWBC HOLDINGS, INC.

ARTICLE I

The name of the corporation is RWBC Holdings, Inc. (the "Corporation").

ARTICLE II

The authorized capital stock of the Corporation shall consist of 1,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE VI

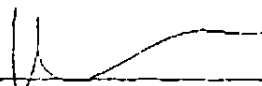

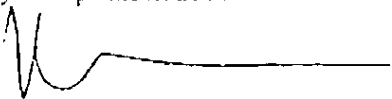
