

Article VI

Employee Right to Petition

1) Employees may petition for change to any and all matters related to their employment with this corporation through a majority vote (of employees). If the majority of employees vote to affirm the petition, the shareholders of this corporation must vote to affirm or deny the petition. The employees shall also vote to affirm or deny the petition. Shareholders shall receive 4 votes collectively. Employees shall receive 4 votes collectively. In order to ratify a petition, the petition must receive at least 5 votes of affirmation. Votes for each respective group (shareholders and employees) will be counted on a pro-rata basis.

Article VII

Decision Making Protocol for Matters Outside of the Scope of Ordinary Business

These decisions shall require a majority vote of shareholders.
