



The undersigned, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is: Octopus Express Car Wash 434, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal office of the Corporation is 510 State Road 434, Winter Springs, FL 32708.
