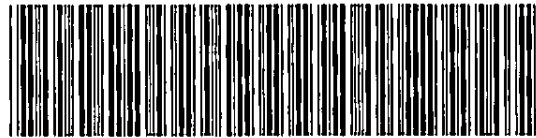

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of this corporation is Treasure Coast Pizzerias, Inc.


### ARTICLE IX - INDEMNIFICATION

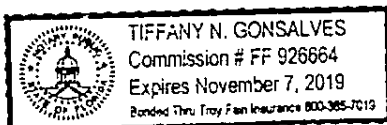


