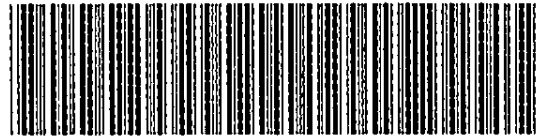


ARTICLE XI


