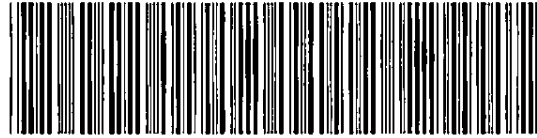

Effective date of dissolution : December 26, 2022




