We, the undersigned, hereby execute these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, rights, privileges, immunities and habitaties of corporation for profit.

#### ARTICLE TWO

The general nature of the business to be conducted shall be:

The corporation may original in any activity or business permitted under the laws of the United States of America and the State of Florida, and additionally:
