

ARTICLES OF INCORPORATION OF TOTAL CARE, INC.

corporation, a natural person

The undersigned subscriber to these Amended articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be **Total Care**, **Inc.** The principal place of business shall be:

6801 Lake Worth Road, Suite 302 Greenacres, Florida 33467

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory, nation or planet.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to issue and have outstanding at any one time shall be two hundred and fifty million (250,000,000) shares that are to be divided in two classes as follows:

Two hundred million (200,000,000) shares of Common Stock, \$0.0001 par value per share and fifty million (50,000,000) shares of Preferred Stock having a par value of \$0.0001 per share. At this time, the Company is designating 1,000,000 of the Preferred Shares as "Class X Shares", and such shares will collectively and for 10 years as of this date, vote equal to 50.1% of all shares outstanding of Total Care, Inc. in all matters requiring a shareholder vote. These 1,000,000 shares will be issued to Guillama 2, Inc. (G2) as founding shareholder, and at this time will be voted by Noel J. Guillama as president of G2, and will be voted by any and all subsequent person(s) holding the title of President of G2. These shares will have no economic, liquidation, or distribution value, only the preferential voting right.
